Laumeier Sculpture Park Photography and Film Policy

Laumeier Sculpture Park, while an open-air museum and public sculpture park, restricts photography and filming of its sculpture collection to avoid conflicts with copyright law that protects artist rights. Many of the sculptures on view at Laumeier are part of the permanent collection and others are on temporary or long-term loan to the park. In either case, neither Laumeier Sculpture Park nor St. Louis County Parks have secured permission from the multiple artists for unrestricted reproduction (photography and film included) of their creative works. The copyright, which governs reproduction rights, to the individual works of art are held by the artist themselves or their estates. Laumeier makes no claim to represent the copyright holders nor does Laumeier provide permission for third parties to photograph or film artwork for distribution without the express written permission of the copyright holder.

Laumeier values the experience of our visitors and places great importance on the safety of our visitors. To guarantee a safe and quality experience for all visitors, Laumeier limits film and photography under the following regulations:

- Laumeier Sculpture Park allows visitors to photograph the exterior sculpture collection and special events for their own personal use, not including posting of images (still or moving) on the Internet (World Wide Web) or other electronic/digital platforms.
- Photography is permitted during normal park hours: daily from 8:00 AM – 30 minutes after sunset.
- Photography must be conducted without disruption to Laumeier Sculpture Park operations or limitation to the accessibility of exhibitions, entrances/exits, trails, and high traffic areas.
- Photography is not allowed in the Museum Galleries (with or without the aid of artificial light).
- We reserve the right to refuse permission or terminate a shoot at any time if it is not in the best interest of guests, donors, artists represented in our collection, the institution or conflicts with Laumeier Sculpture Park's mission.
- All photography or filming of a non-personal nature (i.e. editorial, commercial, advertisement) must be approved by Laumeier Sculpture Park one week (7 days) prior to shooting.
- Laumeier Sculpture Park reserves the right to approve final content for any publication in any form in which images of Laumeier Sculpture Park will appear.
- Laumeier Sculpture Park assumes no responsibility for any royalties or fees claimed against the applicant or Laumeier by third parties.
- These rules are subject to change without prior notice at the discretion of Laumeier Sculpture Park.
